

### Introduction

In the higher education system of our nation, racial harassment is a distressing reality. Ragging is still viewed by many as a way of "familiarization" and a "initiation into the real world" for young college-bound students despite the fact that it has destroyed the careers of thousands of bright students over the years and claimed hundreds of innocent lives.

In pursuance to the Maharashtra Prohibition of Ragging Act 1999 and the Judgement of the Hon'ble Supreme Court of India dated 8.5.2009 in Civil Appeal No. 887/2009) the "UGC" Regulations on Curbing the Menace of Ragging in Higher Educational Institutions, 2009" was formed. The government has sent a circular to universities and colleges titled "Curbing the Menace of Ragging in Higher Educational Institutions" and has also published notices in the newspapers in this regard. These directives were later notified and are to be mandatory followed by all universities and colleges.

The Anti-Ragging Committee has been established for the Prevention and Prohibition of Ragging in accordance with the rules and regulations.

## What is Ragging?

Any disorderly conduct, whether by words spoken or written, or by an act, that has the effect of teasing, treating, or treating rudely any other student, engaging in rowdy or undisciplined activities that causes or is likely to cause annoyance, hardship, or psychological harm, or raising fear or apprehension thereof in a fresher or a junior student, or asking the student will not in the ordinary course, and which has the effect of causing or generating a sense



## FUNCTIONS OF ANTI-RAGGING COMMITTEE


- Every institution University including Deemed to be University imparting technical education shall constitute a Committee to be known as the Anti-ragging Committee to be nominated and headed by the Head of the Institution, and consisting of representatives of civil and police administration, local media, Non- Government Organizations involved in youth activities, representatives of faculty members, representatives of parents, representatives of students belonging to the fresher's category as well as senior students, non-teaching staff; and shall have a diverse mix of membership in terms of level as well as gender.
- It shall be the duty of the Anti-Ragging Committee to ensure compliance with the provisions of these Regulations as well as the provisions of any law for the time being in force concerning ragging; and also to monitor and oversee the performance of the Anti-Ragging Squad in prevention of ragging in the institution.

## Functions of Anti-Ragging Squad

- It shall be the duty of the Anti-Ragging Squad to be called upon to make surprise
  raids on hostels, and other places vulnerable to incidents and having the potential
  for ragging and shall be empowered to inspect such places.
- It shall also be the duty of the Anti-Ragging Squad to conduct an on-the-spot enquiry into any incidents of ragging referred to it by the Head of the institution or any member of the faculty or any member of the staff or any student or any parent or guardian or any employee of a service provider or by any other person, as the case may be; and the enquiry report along with recommendations shall be submitted to the Anti-Ragging Committee for action.
- Provided that the Anti-Ragging Squad shall conduct such enquiry observing a fair
  and transparent procedure and the principles of natural justice and after giving
  adequate opportunity to the student or students accused of ragging and other
  witnesses to place before it the facts, documents and views concerning the incidents
  of ragging, and considerations such other relevant information as may be required.

# Mechanism of Anti Ragging Committee and actions to be taken in the event of Ragging


- The Anti-Ragging Committee of the institution shall take an appropriate decision, with regard to punishment or otherwise, depending on the facts of each incident of ragging and nature and gravity of the incident of ragging.
- Depending upon the nature and gravity of the offence as established the possible punishments for those found guilty of ragging at the institution level shall be any one or any combination of the following:
  - i) Cancellation of admission
  - ii) Suspension from attending classes
  - iii) Withholding/withdrawing scholarship/fellowship and other benefits
  - iv) Debarring from appearing in any test/examination or other evaluation process
  - v) Withholding results
  - vi) Debarring from representing the institution in any regional, national or international meet, tournament, youth festival, etc.
  - vii) Suspension/expulsion from the hostel
  - viii) Rustication from the institution for period ranging from 1 to 4 semesters
  - ix) Expulsion from the institution and consequent debarring from admission to any other institution.
  - x) Collective punishment: when the persons committing or abetting the crime of ragging are not identified, the institution shall resort to collective punishment as a deterrent to ensure community pressure on the potential raggers.

An appeal against the order of punishment by the Anti-Ragging Committee shall lie, (i) In case of an order of an institution, affiliated to or constituent part, of the University, to the Vice-Chancellor of the University; (ii) In case of an order of a University, to its Chancellor. (iii) In case of an institution of national importance created by an Act of Parliament, to the Chairman or Chancellor of the institution, as the case may be

## ANTI-RAGGING ACT PENALTY

- Ragging is a criminal offence and a strict disciplinary action will be taken as the law.
- Maharashtra Prohibition of Ragging Act 1999 which is an effect from 15<sup>th</sup> May, 1999 has the following provisions for Action against Ragging.
- Ragging within or outside of any educational Institution is prohibited.
- Whosoever directly or indirectly commits participates in abets or propagates ragging within or outside any educational Institution shall on conviction be punished with imprisonment for a term up to 2 years and/or penalty which may extend to Twenty-Five thousand rupees.


#### Measures for Prevention of Ragging

- The advertisement for admissions shall clearly mention that ragging is totally banned / prohibited in the Medical College/Institution and anyone found guilty of ragging and/or abetting ragging is liable to be punished appropriately.
- The brochure of admission/instruction booklet for candidates shall print in block letters these
  Regulations in full (including Annexures). 'Prospectus' and other admission related
  documents shall incorporate all directions of the Hon'ble Supreme Court and /or the Central
  or State Governments as applicable, so that the candidates and their parents/ guardians are
  sensitized in respect of the prohibition and consequences of ragging.
- A Brochure or booklet/leaflet shall be distributed to each student at the beginning of each
  academic session for obtaining undertaking not to indulge or abet ragging and shall contain
  the blueprint of prevention and methods of redress.

- The application form shall also contain a printed undertaking, preferably both in English/Hindi and in one of the regional languages known to the institution and the parent/guardian (English version given in Annexure I, Part II), to be signed by the parent/guardian of the applicant to the effect that he/ she is also aware of the law in this regard and agrees to abide by the punishment meted out to his/ her ward in case the latter is found guilty of ragging and/or abetting ragging.




